Class A—(includes spouse/children under 23) Full golf privileges (7 days per week), \$275 monthly dues

Weekday Membership (includes spouse/children under 23) Monday—Friday Golf Membership, \$1750 Annual dues (or 150 Monthly)

Weekend Membership (includes spouse/children under 23) Sat/Sun/Holiday Golf Membership, \$1750 Annual dues (or 150 Monthly)

Senior Membership—Ages 62+ (includes spouse) Monday – Friday Golf Membership, \$1650 Annual dues (or 150 Monthly)

Associate A - Ages 30 to 39 (includes spouse/children) \$1500 annual dues or \$500 down, \$150/mo (7 months), \$25 monthly food/bev minimum

Associate B - Ages 20 to 29 (includes spouse/children) \$900 annual dues or \$250 down, \$100/mo (7 months), \$25 monthly food/bev minimum

Junior Membership – Ages 14 to 19 (Monday – Friday golf privileges) \$400 annual dues, \$150 range pass available, no monthly food/beverage minimums, no guests

## General Conditions of Membership

- 1. Initiation fees and dues are non refundable.
- 2. All new members will be required to have a credit card on file as all monthly charges will be automatically charged, a paid monthly statement will be mailed to your home.
- 3. If any golf membership is not held for a period of at least 12 months a termination fee of \$1000 will be charged to the credit card on file. After a membership is held for a period of at least 12 months, there will be no termination fee.
- 4. If payment is not made by credit card on file, bills past due in excess of 30 days will be considered cause for suspension and a service charge of 1.5% per month (18% annual percentage rate) will be applied on past due amounts. If it should become necessary for the Club to institute proceedings to collect any delinquent accounts, the member shall be liable for all fees and costs including any attorney's fees associated.
- 5. The club will not be responsible for loss or damage to property of Members on the Club property, whether in lockers, bag storage or elsewhere.
- 6. No solicitations are to be made on the Club's property at any time.
- 7. No reprimand shall be given to employees by any Members of the Club. Complaints concerning normal operations of the Club, the Club employees and other matters are to be made in writing, signed and directed to the Director of Golf.
- 8. In the event of a divorce the membership may be retained by the Member listed as member of said membership or as decreed by court order.
- 9. Applicant understands that membership may be suspended or cancelled without refund, if Club rules or policies are violated by a member and or their guest.
- 10. Food and Beverage Minimums are billed monthly (based on your billing cycle). These purchases must be charged to your account during your billing cycle. If you fail to meet all or part of your minimum, you will be billed for the remaining unused portion on your normal monthly statement. (*does not include tax/gratuity*)
- 11. I have receive a copy of the Morris Country Club Membership Guidelines and Rules and understand and will adhere to all of the conditions within.
